

AIMExpo AFFIDAVIT OF LIABILITY/PUBLICITY RELEASE

1. I represent that I understand and have fully complied with the Official Rules of the competition (attached and incorporated herein by reference) and that I have committed no fraud or deception in entering the competition or in claiming any prize that may be awarded to me. I further represent that I am a builder/owner of a custom motorcycle and of legal age of majority in my jurisdiction of residence (and at least 18), I am a legal resident of my country, and that I have the right to enter into this Agreement.

2. I understand that I am responsible for all costs associated with transporting my custom-built motorcycle to and from the competition and any fees associated with moving the Motorcycle into the show hall and compliance with all show hall rules and regulations. I further understand that it shall be my sole responsibility to insure my property against loss, damage or theft.

3. I warrant and represent that the Motorcycle I submitted is owned and/or built by me. If requested to do so by Sponsor, I warrant and represent that I am able to provide (a) proof of retail value of the Motorcycle in a form acceptable to Sponsor, and (b) verification of ownership of Motorcycle in a form acceptable to Sponsor.

4. I understand that Released Parties (as defined below) are not responsible for any damage, theft or loss to the Motorcycle resulting, in whole or in part, directly or indirectly, from participation in the competition (including any damage or loss which occurs while shipping the Motorcycle to and from the competition). I further understand that any insurance relative to participating in the competition is my sole responsibility (including any insurance associated with shipping the Motorcycle to and from the competition).

5. I understand that I will be required to have the Motorcycle present at the competition, at my own expense, for set-up by 6 p.m. local time on the Tuesday before the show opening and available on display at the competition from show opening on Thursday to show close on Sunday. I further understand that I must remove the Motorcycle by 10 p.m. local time on Sunday and that failure to comply with any of these requirements may result in disqualification.

6. I grant Sponsor and its designees the right to photograph the Motorcycle and agree Sponsor and its designees shall have the worldwide perpetual right to exploit, edit, modify, and distribute such photographs as well as my entry (including photographs submitted as part of entry) and all elements of both, in any and all media now known or not currently known (including in current and future advertising and promotions of the Contest on its website), throughout the world in perpetuity without compensation, permission or notification to me or any third party.

7. As provided in the Official Rules, I hereby agree to be responsible for all federal, state and local taxes and any other costs or expenses incurred in accepting or using any prize that may be awarded to me.

8. I grant Sponsor and its designees the right to use my name, company name, trademarks, logos, entry, biographical information, voice, performance, photograph, image and/or likeness for trade, advertising, publicity and promotional purposes in any and all media, now or hereafter known, worldwide and on the Internet, and in perpetuity, without compensation, notification or permission, unless prohibited by law.

9. I understand and acknowledge and hereby release, discharge and hold harmless Sponsor, the venue in which the competition takes place and its owners/management company, Sponsor's sponsors including without limitation, and their respective parents, affiliates, subsidiaries, and advertising and promotion agencies, and all of the officers, directors, shareholders, employees, agents and representatives of the forgoing (collectively, the "Released Parties") from any and all injuries, liability, losses and damages of any kind to persons, including death, or property (including the Motorcycles) resulting, in whole or in part, directly or indirectly, from entrant's participation in the competition or any competition-related activity (including any shipping, travel or activity related thereto), the acceptance, possession, use or misuse of any prize that may be awarded to me or the use by Released Parties' of any rights granted herein.

10. I also acknowledge that the Sponsor has not arranged for nor carries any insurance of any kind for my benefit or that of my heirs, executors and administrators relative to my use of the prize awarded to me; and that I am solely responsible for obtaining and paying for any life, accident, automobile, property or other insurance relative to the prize awarded to me.

11. I understand that I am entitled to receive only the announced prize and that such prize is non-transferable and that no substitutions or cash equivalents will be made except at the sole discretion of the Sponsor or as provided in the Official Rules of the Contest.

12. Released Parties are not responsible for any cancellations, delays, diversions or substitutions or any act of omission whatsoever by the persons or entities providing any services in fulfilling any prize that may be awarded to me.

13. I warrant and represent that I have the full right and power to enter into this Affidavit/Release, and that the terms of this document do not in any way conflict with any existing commitment on my part.

14. I agree that this Affidavit/Release supersedes any prior understandings between myself and the Sponsor relating to the rights granted herein and no provision of this Affidavit/Release can be modified by any other instrument, invoice or document unless in writing and signed by the parties hereto.

15. It is understood and agreed that this is a complete RELEASE and DISCHARGE of all claims and rights of the undersigned against the Released Parties, and that no action will be taken by or on behalf of the undersigned with respect to any such rights; it being understood that this release shall be binding upon the parents, guardians, heirs, executors, and administrators of the undersigned.

16. If any statement made by me in this Affidavit/Release is false or if I am otherwise deemed ineligible or unable to participate in the Contest or accept a prize for any reason, then, in addition to any other remedies that may be taken against me, I agree to return to the Sponsor any prize that may be awarded to me, or its cash equivalent.
