# 2017 AIMExpo Championship of the Americas

Official Rules

### **Entry Process**

- Register on-line at www.AIMExpoUSA.com
- Complete entire entry form and affidavit of Liability and Publicity Release and sign electronically.
- Specify desired class you wish to enter:
  - 1. **Free Style:** Anything goes, 2 or 3 wheel drivetrain/chassis motorcycle configuration as defined by the DMV. The only limitation is the builder's imagination and resources.
  - 2. **Retro Custom:** Must have a pre-84 OEM engine, replica engines are not allowed. Custom or modified stock frames are acceptable. Must be a 2 or 3-wheel motorcycle configuration as defined by the DMV.
  - 3. **Street Custom:** Must have a major OEM engine and frame. Neck may be cut to rake frame. Hard tail sections and wide tire kits are acceptable. Must be a 2 or 3-wheel motorcycle configuration as defined by the DMV.
  - 4. **Performance Custom:** Must have engine and/or suspension upgrades. Does not have to be street legal. Modified or competition specific frames and stretched swing arms are acceptable. All forms of competition (drag racing, class C, road racing and off-road) 2 or 3 wheel motorcycle configurations as defined by the DMV are acceptable.
  - 5. **Peoples' Choice:** The one favorite bike chosen by popular vote
- E-mail 2 photos of bike, 1 left side straight on and 1 right side straight on, to bkay@mic.org. You may also text photos to Bob Kay at 817-312-0380
- Pay entry fee through Pay Pal link and save confirmation #. Free Style entry fee is \$150 and all other classes are \$75. Entry fees include 2 exhibitor passes per bike.

# **Eligibility**

- Incomplete entries will be disqualified
- The AIMExpo Championship of the Americas is open to all builders/owners of custom 2 or 3 wheel motorcycle configurations as defined by the DMV that are legal residents of North American, Central American and South American countries that are of legal age of majority in their jurisdiction of residence.

 All entry forms and photos become the sole property of AIMExpo and will not be returned.

### **Judging Rules**

- Judging will be conducted by a "Peer Review" of fellow builders entered into the AIMExpo Championship of the Americas. In addition AIMExpo has the option to invite VIP Industry expert judges. One voting form will be issued to each builder or VIP upon site registration regardless of the number of bikes entered. Competitors cannot vote on their own bike.
- Correctly tallied and completed judging forms must be returned to the
  registration desk or deposited in a Peoples' Choice ballot box by the stated
  deadline to be included in the voting process. In the event of a tie on points
  for any award, the entry with the most first place votes of the tied entries will
  be deemed the winner. Any disputes will be decided by the Sponsor and
  considered final.
- Peoples' Choice will be decided by popular vote open to all attendees and exhibitors.

# **Bike Displays**

- AIMExpo will provide a display area, some will be elevated as arranged for presentation, and an 11" x 17" display sign provided by the sponsor accompanying the motorcycle. The information provided on the entry form will be used to populate the display sign.
- No other items may accompany the motorcycle in the display. This includes, but is not limited to; turn tables, lights, mirrors, trophies, pictures or models. The owners/builders and or models may stay within the vicinity of their motorcycles; this is actually encouraged, and promote their bike/company. Business cards and or literature may be handed out but in no way surplus cards or literature may be stored visible to attendees.

#### **Prizes**

- Free Style
  - Winner: Up to \$7,500 reimbursement for expenses to attend the 2018 AMD World Championship of Custom Bike Building including motorcycle transit by ship, transit insurance, air fare and lodging for the builder. Qualified reimbursement is only eligible for the 2018 AMD World Championship of Custom bike Building, is not transferable and will be paid net/45 upon receipt of an invoice indicating the actual

service. Entry must be ready for shipping by August 1, 2018 to allow for customs paperwork and transit time.

o Runner Up: \$2,500 in merchandise credit

#### Retro Custom

Winner: \$2,000 in merchandise creditRunner Up: \$500 in merchandise credit

#### Street Custom

Winner: \$2,000 in merchandise creditRunner Up: \$500 in merchandise credit

#### Performance Custom

Winner: \$2,000 in merchandise creditRunner Up: \$500 in merchandise credit

### · Peoples' Choice

Winner: \$500 in merchandise creditRunner Up: \$250 in merchandise credit

#### General

- All motorcycle entries must be able to start, run, move under their own power and stop. Sponsor reserves the right, at its sole discretion, to require verification of ownership and retail value of any custom motorcycle in a form acceptable to the Sponsor.
- Sponsor reserves the right to disqualify any entry it deems to be offensive, inappropriate, or not in keeping with sponsor's image or that is otherwise not in compliance with the official rules.
- Participation in the AIMExpo Championship of the Americas means the entrants agree to (a) abide by the rules of the Sponsor and judges, (b) to release and hold harmless the Sponsor/AIMExpo, the Sponsor's sponsors and their respective parents, affiliates, subsidiaries, and advertising and promotional agencies, and all of the officers, directors, share holders, employees, agents and representatives of the collectively released parties from any and all injuries, liabilities, losses and damages of any kind to persons including death, or property damage resulting, in whole or in part, directly or indirectly, from the entrant's participation in the competition or any competition-related activity including travel and shipping to and from, the acceptance, possession, use or misuse of the awarded prize or use by the

Released parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this competition or downloading materials from or use of the website.
